Our nursery's current pattern of delivery for children to access stand alone FEL is to offer five afternoon sessions of 2.5 hours duration.

Parents/Carers should note that they are entitled to claim the remaining 2.5 hours at another provider.

Children aged three and over, by the dates in **Table 1**, are eligible to receive the nursery entitlement for up to fifteen hours per week. This will be deducted at source and only the balance invoiced.

The maximum claimable for a full day is six hours and for a morning it is three hours.
